Following a meeting with Roads lanager Tracey Urray the Sutherland County committee agreed that they would promote a raffic Regulation order to introduce an extension of 30mph limit to beyond Ardgay Game & Omph on the remainder of the stretch together with traffic calming measures. imate Change issues – this is a standing item on our agenda, so any ideas for local action					

etc can be discussed. We welcomed Amanda Coghill from North Highland Climate Hub to our April meeting who are central to organising the upcoming Highland climate Festival. Community Benefit funds. The cc has continued to consider applications to the Beinn

Tharsuinn & Beinn nan Oighrean CB funds. Coire na Cloiche funds continue to support local organisations - Ardgay Hall, Culrain Hall Gearrchoille Community Wood, KoSHS. In addition

- we have started using these funds to make annual awards to Gledfield PS parents assoc & KoSDT Helping Hands fund.
- Proposed development at Gledfield: At our Feb meeting the planning application 21/05786/FUL for development of 47 holiday lodges & renovation & extension of existing building to form a restaurant & spa was discussed. The community council comments to the planning authority raised several concerns raised by residents at the meeting water supply, sewage disposal, core path network, preservation of mature lime trees & climate issues, whilst acknowledging the benefits that the development could bring to our area & concluded that if concerns could be suitably addressed ADCC would welcome the development.
- Core Paths: After several years of lapsed membership, A&DCC once again joined Scotways, national charity for protecting rights of way & outdoor access. We are hoping to work with Matt Dent, THC access officer to increase the signage & encourage greater use of local core paths & ROW.
- Ardgay, Bonar Bridge & Lairg community action plan. SSE has commissioned Voluntary
 Action in Badenoch & Strathspey (VABS) to work with Voluntary groups Sutherland (VGS) to
 produce a new community action plan. A large number of community groups have been
 approached to be represented on a panel which will look at a variety of local issues &
 endeavour to find a way these can be addressed. This touches on what has long been a
 talking point for us how to engage with a larger number of residents & gauge local opinion
 about relevant issues.

A big thank you to all our cc members - Buster Crabb, Silvia Muras, Rob Pope, John Denniston, Marion Turner & Andy Wright for all the work they have done in various ways to address local issues. BW was elected chairperson, SM vice chairperson, MT secretary, JD treasurer. Thank you to all concerned for giving up their time to help their community.

5. Treasurer's Report:

- Treasurer's report for the financial year 2021-2022: The balance of A&DCC bank accounts, as of 5th April 2022 was: £48,830.84 of which: £48,421.67 was in restricted accounts, as follows: £24,099.37 in the Beinn nan Oighrean (BnO) account; £22,827.02 in the Coire na Cloiche (CnC) account; £ 1,422.08 in the Beinn Tharsuinn Windfarm (BTWF) account; £ 73.20 in the RWE Path account; £370.20 (rounded up) was in the admin account; £ 38.98 (rounded up) was in the Wind Farm admin account.
- Admin: During the financial year, the Highland Council (THC) gave the community council £485.03 for administrative work. In addition, we received £10.00 in donations. Total admin expenditure (Zoom licence, minutes secretary payments, insurance etc.) for the period was £690.66 split evenly across THC admin fund and the windfarm fund.

6. Report re: Beinn Tharsuinn, Beinn nan Oighrean & Coire na Cloiche Community Benefit funds:

- **Beinn Tharsuinn Windfarm (BTWF)**: The BTWF account is intended for use by A&DCC for community needs/projects. The total for grants received was £1,500.00 plus £36.68 which was transferred from the toilet fund and disbursed during the period was £1,045.60 which included: payments towards planters and an award for work on flowers and plants.
- Coire na Cloiche (CnC) Windfarm account: Ardgay & District Community Council has decided that a proportion of this money should go to supporting groups that have assets that need maintaining such as buildings. The remainder is available awards by application directly to A&DCC. Guidelines and an application form can be downloaded from the A&DCC web site. A total of £20,627.02 was received this financial year and £13,110.00 was paid out as grants to the Gearrchoille Community Wood; Ardgay Public Hall; Culrain Hall; Kyle of Sutherland Heritage Society; Gledfield School Parents' Council; Ardgay Badminton Club.
- Beinn nan Oighrean (BnO) Windfarm account: The BnO account is intended for grants to community projects of up to £250. Total income this year was £3,529.76, whilst expenditure was £220, being a grant for the Kyle of Sutherland Gala.
- **RWE Path account:** No income was received in this financial year and nothing was spent on improving paths.
- BW shared tables listing awards in Chairperson's report above. Will share recent awards in subsequent issues of the Kyle Chronicle.
- 7. Appointment of Office Bearers: All members of the Community Council stood down. John Denniston has stood down from CC for health reasons. Cllr Michael Baird (ex officio member) took the chair for the purpose of electing the Chair. Office bearers were elected as follows:

 - Representatives to Beinn Tharsuinn Windfarm Company: Betty Wright and Rob Pope.
- **8. Any other business:** None presented.

9. Dates of meetings until next AGM:

- BW proposed to retain current scheduled of 2-month on, 1 month off, with meetings to be held in August, September, November, December, February, March, May, June.
